1. At 6:00 p.m., a work session was held regarding the 2003 Holiday Parade.

- 2. Acceptance of Minutes August 4, 2003 Voted to accept and approve the City Council minutes of the August 4, 2003 meeting.
- 3. Public Comment Session There were three speakers Robin Najar, Bernie Pelech (State Street Pocket Park); and Peter Bresciano (Recreation Department).
- 4. Resolution Authorizing a Supplemental Appropriation for Necessary Expenditures for the Operation of the Fire Department in the amount of \$128,000 - Held a public On a roll call vote 6-3, voted to adopt the resolution authorizing a supplemental appropriation in the amount of \$128,000. Mayor Sirrell, Councilors Grasso, Hynes, Pantelakos, Marconi, and Assistant Mayor Hanson voted in favor. Councilors Lown, Whitehouse, and St. Laurent voted opposed.

  - First reading of Ordinance amending Chapter 10, Article II, Section 10.202 Location by the addition of the following language – Pursuant to Article II, Section 10.203(7) of the 1995 Zoning Ordinance, as amended all City owned land not shown in the Municipal or Natural Resource Protection Districts shall be deemed to be in the Municipal District and when so identified shall be placed in that district

Voted to pass first reading of proposed amendments to the 1995 Zoning Map and 1995 Zoning Ordinance as presented, and schedule a Public Hearing and second reading at the September 8<sup>th</sup> City Council meeting.

First reading of Ordinance amending Chapter 10, Article III, Section 10.301(A)(7) General Requirements Voted to pass first reading of proposed amendments to Article III, Section 10.301(7) of the Zoning Ordinance, and schedule a Public Hearing and second reading at the November 17<sup>th</sup> City Council meeting and further refer this matter to the Planning Board for a report back prior to November 17<sup>th</sup>.

   Speed Limits Buckminster Way 20 MPH Voted to pass third and final reading.

Mayor Sirrell, Councilors Grasso, Hynes, Pantelakos, Whitehouse, Marconi, and Assistant Mayor Hanson voted in favor. Councilors Lown and St. Laurent voted opposed.
- 16. <u>Appointments</u> Considered the reappointment of Paige Roberts to the Historic District Commission. This appointment will be voted on by the City Council at the September 8<sup>th</sup> meeting. Voted to reappoint John Golumb to the Historic District Commission until June 1, 2006.
- 17. <u>Invitation</u> Mayor Sirrell announced an invitation to attend the Change of Homeport Ceremony Saturday, September 27, 2003 at 11:00 a.m. on the pier at Portsmouth Naval Shipyard.
