- I. **CALL TO ORDER** Chair Stevens called the meeting to order at 7:03 p.m.

- IV. **PLEDGE OF ALLEGIANCE** Chair Stevens led in the pledge of allegiance.
- V. **SPECIAL PRESENTATION PROJECT** SAFETY AWARDS 1st ENGRAVED SLATE TO PRINCIPAL STOKEL Ms. Karen Webb, Mr. Daniel Edgecomb and Ms. Susan Christmas presented Principal Stokel with the first numbered engraved slate harvested from the 1930's roof of the Portsmouth Middle School. This fund raiser for Project Safety depicts the original 1930's building etched on roof tile slates. The general public can now purchase historical limited edition slates at the middle school, at certain location downtown or directly from Project Safety's website. There are 299 for sale at \$200.00 each. All proceeds go directly to Project Safety.

- VII. **DISCUSSION OF FY14 BUDGET** Board members asked the following clarifying questions before agreeing to vote on a final budget Tuesday, February 12, 2013.
 - a) Where did funding from the Resource Office come from? Funding was realized through a retirement and a person leaving the district. Savings from these positions are able to now fund the districts portion of the SRO and the budget will still remain under 4%.
 - b) M. LaPage proposed that \$25,000.00 be added to the budget for a new sound system at the high school auditorium in hopes that matching funds can be raised.

c) Mr. LaPage proposed that \$40,000.00 be added to the budget to fund a full time substance abuse counselor position.

Board members discussed the two proposals made by board member LaPage in length and decided they were ready to vote on the final budget Tuesday, February 12, 2013.

Ms. Walker announced that the Governor was going to TSN February 8th and that she would be calling in to advocate for the return of CHINS. Ms. Walker encouraged other board members to do the same.
