In the absence of Chairman Marchewka, City Councilor Lazenby served as Pro tem Chair and opened the meeting at 7:35 a.m.

Approval of draft meeting minutes of November 9, 2018

Commissioner Watson moved and Commissioner Gold seconded a motion to approve the draft meeting minutes of November 9, 2018. The motion carried unanimously.

Presentations

- Greater Portsmouth Chamber Collaborative semi-annual report on Tourism and Business Development, Valerie Rochon and Katti Mowers distributed copies and presented the report for the period June 1 – November 30, 2018. The report covered the following:
 - Frontier Airlines has started service to Portsmouth from Orlando. They are interested in inbound marketing. This has caused Allegiant to also be interested in marketing the destination.
 - o Destination marketing including the Official Map and Harbor Guide to Portsmouth and the Seacoast and the Seacoast brochure that is popular in NH rest stops.
 - o Rollout of experiential retail gift box for travel writers including Travel & Leisure Magazine and Forbes
 - O Attendance and outcomes of Consumer Travel Shows in NYC, a new AAA Travel Show at Gillette Stadium in Foxborough (in lieu of the declining Boston Travel Show) and the MGM Show in Springfield, MA (in lieu of Connecticut Travel Show) and indirect marketing to Canada through the New England Travel Center and fam tours
 - o Public relations consultant press results.
 - o Analytics for the GoPortsmouth.com website
 - Visitor Center Survey results
 - o Rooms and Meals revenues
 - o Lodging Occupancy data (~80% in summer months)
 - Small business and economic development initiatives including the Manufacturing Roundtable,
 Portsmouth High School Career Technical Pathways Program, Trend Talks, Workforce
 Attraction/Retention/Housing, Transportation, and Education

Commissioners discussed the practice of targeting press versus Instagram or other social media outlets as well as the benefits (less cost and reaching a different traveler demographic) and drawbacks (poor blog posts) of using social media for destination marketing.

Also discussed was the challenges of the online booking feature of the GoPortsmouth.com created by website consultant Entopia. The firm is currently working on the compatibility issue between local hotels' online booking tool and the Chamber's web tool.

Lastly, Commissioner Watson raised the concept of employer contributions to a fund for development of workforce housing. Under this scenario, employee compensation would take into account the employer's

contributions for an employee housing unit constructed by a contracted developer. Commissioner Zolla thought that it might work for a short term subsidy versus a long-term asset due to costs inherent in housing development.
