MINUTES OF THE OCTOBER 30TH, 2019 POLICE COMMISSION MEETING

I. <u>CALL TO ORDER</u>: The October 30th, 2019 monthly Police Commission meeting was called to order at 3:55 p.m. in the Wm. Mortimer Room of the police department for the purpose of going into non-public session. Commission Shaheen was present via telephone.
