Commissioner Kennedy motioned to accept the Executive Director's report, as presented. Commissioner Jewett seconded the motion. The motion passed, with all in favor.

# IV. NEW BUSINESS

#### 1. Vote on Vice-Chair Position

Commissioner Kennedy nominated Commissioner Ferrini for the position of Vice-Chair.

Commissioner Kennedy motioned to close the nominations in order to put the nomination to a vote. Commissioner Pickering seconded the motion. The motion carried, with all in favor.

Commissioner Kennedy motioned to approve the nomination of Commissioner Ferrini to the position of Vice Chair. Commissioner Pickering seconded the motion. The motion passed, with all in favor.

# 2. Resolution No. 2019-006 – Adoption of 2020 Operating Budget

Finance Director Valerie Labrie summarized her memo to the Board of Commissioners, pointing out the differences in budget items compared to the previous year.

Commissioner Kennedy motioned to adopt the 2020 Operating Budget. Commissioner Pickering seconded the motion. The roll call vote was as follows:

# 4. Resolution No. 2019-005 – Proposed Payment Standards

# 5. Resolution No. 2019-007 – Adoption of Conflict of Interest Policy

In regards to the 160 Court Street project, we are anticipating to have a decision on the appeal in early 2020. The litigation has delayed us a year. Construction prices went up 8% in the meantime.

Commissioner Kennedy motioned to transfer \$550,000 from the COCC accounts to the Court Street construction accounts. Commissioner Pickering seconded the motion. The motion passed, with all in favor.

Mr. Welch brought up that an approval should be made by the Board for PHA to purchase and take the title of 152 Court Street.

Commissioner Kennedy motioned to table the decision to January 8 in order to get Attorney John Bosen's input. Commissioner Pickering seconded the motion. The motion passed, with all in favor.

# A. WAIT LIST

Craig introduced Hadley Barndollar from Seacoast Media Group. The total applicants in November were 660. Almost 40% of applicants are over the age of 62. 32% are non-elderly but disabled, so they qualify for public housing. 214 are in that category. The total homeless applicants are at 159 and make up ¼ of people on waitlist. Homelessness is a self-affidavit. Some may not be in a shelter or in woods. Some may have roof over their head, couch surfing. PHA houses dozens of people from Crossroads each year.
