I. <u>CALL TO ORDER</u>: The August 27<sup>th</sup>, 2019 public session of the monthly Police Commission meeting was called to order at 5:30 p.m. in the Eileen Dondero Foley Council Chambers.

**II. PLEDGE OF ALLEGIANCE:** Commissioner Splaine led the Pledge of Allegiance.

#### III. ACCEPTANCE OF THE MINUTES:

The Chair asked for a motion to accept or amend the minutes of the July 23<sup>rd</sup>, August 2<sup>nd</sup>, August 20<sup>th</sup>, and August 22<sup>nd</sup> meeting minutes.

## VI. NEW BUSINESS:

## A. POLICE COMMISSION:

1. Commissioner Onosko: The Chair indicated a number of officers had just been promoted to fill open positions, and the official vesting of rank ceremony will take place as part of the September monthly Police Commission meeting.

#### **B. CHIEF OF POLICE:**

- 1. NH Internet Crimes Against Children Task Force Update: Det. Sergeant John Peracchi, NH ICAC Commander. Det. Sgt. Peracchi gave the Commission a brief overview of the NH ICAC Task Force, making the following points:
  - The first ICAC Task Forces in the United States were formed in 1998. The Portsmouth Police Task Force was one of the original 10 task forces in the country.
  - Now have 61 Task Forces in the Country.
  - Now have about 4500 state and local agencies working with these task forces around the country.
  - Computer crime in increasing exponentially and has increased more than 100% from last year to this year alone. Task Forces must stay current with the never-ending array of apps being pushed out to our kids on almost a daily basis.
  - The role of the task force is to provide the complex investigative support to state and local law enforcement agencies that these crimes require; i.e. the trained forensic investigators who know how to recover images and information from cell phones, computers, and other devices; the trained interviewers who know how to deal with the perpetrators; the technical assistance needed for local law enforcement agencies to investigate crimes where a child has been exploited online, and to help them secure warrants so guilty parties can be arrested and prosecuted.
  - Det. Sgt. Peracchi also talked about satellite labs, and new training resources being developed by his office to further equip his task force, and the state and local agencies they work with.

## 2. Letters of Appreciation:

- A letter from the Board of Directors of GLG Management thanking Chief Merner and the officers who came by to visit the Spinnaker Point neighborhoods during the National Night Out event.
- A note of thanks from Ricci Lumber President, Mr. Edward Hayes, complimenting officers Pearl and Melanson whom he observed questioning an individual at the construction site of the Cate Street townhomes project. The person turned out to be an authorized construction worker. Mr. Hayes said both officers were very courteous and professional, and he appreciated their vigilance. He went on to note a second instance of Officer Potter taking steps to secure and serve a trespass notice to individuals on the construction company's business property.

  - o 65 Summonses, 9 for speeding
  - o 58 Motor Vehicle Accidents
  - o 229 Traffic Enforcement Stops
  - o 686 Stops for May, June, & July combined
  - O Note re: Bartlett Street: a total of 565 Traffic Stops have been made on Bartlett Street in the last 5 years; 78 of them in 2019 to date.
