Dear Counselors,

In examining the allegations that Esther Kennedy violated ethical standards, I suggest that the analysis by the Board is flawed. Looking at the facts of the case, a different conclusion can be easily reached if one considers Ms. Kennedy as a whistleblower. A whistleblower is someone who brings to light a wrongdoing or exposes information or an activity that is deemed illegal, wasteful or fraudulent. Many whistleblowers bring their complaint to someone who they believe will deal with it internally such as a Human Resources department or to a supervisor. Then if the issue is not adequately addressed or corrected, often the whistleblower will then bring the issue to others, such as the media or to others to call attention to the wrong doing. Whistleblowers are protected under the law and retaliation is specifically prohibited.

In this case, Ms. Kennedy brought to the attention of the City Manager the fact that fund raising was on-going for a "non-profit" organization, but the non-profit was not in existence. The consequence of such an activity is that the "non-profit" can face penalties with the IRS. As the City of Portsmouth was involved with the organization and donating resources (which were expected to be reimbursed by the CARES Act) it could be tainted by the wrong doing of the organization. In fact, Ms. Kennedy's interests were at all times aligned with the interests of the residents of Portsmouth. She was advocating for local Portsmouth businesses to benefit, rather than out-of-town businesses.

Ms. Kennedy did not obtain any satisfactory answers from the City Manager. She sought to register the name PopUp Portsmouth to get the attention of the organization so that it would properly proceed with forming the non-profit correctly, not face penalties with the IRS nor involve the City with any associated wrong doing.

Based on Ms. Kennedy's attempt to correct a problem facing the organization, bringing it to the attention of the City and the public, Ms. Kennedy is a whistleblower. She has been retaliated against by a a former City Counselor and the Ethics Board for her actions. Retaliation by the Ethics Board is not the proper response to someone who has made the public aware of wrong doing.

The language used in newspaper articles and in letters to the editor often refers to Ms. Kennedy as being "guilty." The Ethics Board proceeding is a civil matter and this is not a criminal proceeding. The use of language calling someone "guilty" in a civil matter is incorrect and irresponsible. The use of language matters. Punishing Ms. Kennedy for being a whistleblower is not the correct action to take. In fact, her actions in bringing this matter to the public's attention should be applauded.
