#### 1. Update Community Power Coalition of NH (CPCNH)

- Discussion of the proposed HB315
- Rep Cali-Pitts has sponsored the Bill, and since its inception, there have been many amendments
- Webinar was held on January 21, 2021 regarding the Community Power as it relates to the HB315 Bill. Currently the amendments support needs of the communities. (many in attendance community presence from all over the State). Henry Herndon of Clean Energy NH, on the Board f the CPCNH was the main presenter.
- Regarding CPCNH, it allows more flexibility to city residents to have renewable power and saves the City money. You can learn more here:

- Discussion around elements of joining as a member or on the Board.
- John Tabor noted that he is the Council Representative to the Rockingham Planning Commission so we have an ally there.
- The Coalition provides many examples of processes to follow to institute community power here in Portsmouth. We are looking at becoming a member with option to sit on the Board.

## 2. Solar

- Bert reported that Tom Morgan joined the Drawdown Action Committee meeting last night (March 24, 2021) and he and Tom came up with some draft recommended language from our CSP to the Portsmouth City Council.
- Tom explained that in Portsmouth, there's no prohibition against solar fields but there's no explicit language. Ideally, it's the zoning ordinance that would be amended based on Tom's language, noting all the provisions Bert provided (do not have Bert's draft). The question is do we just focus on Tom's letter, and provide recommendations just on the question of solar fields (5 acres or more) or do we expand the language just a bit to make Portsmouth more inclusive of solar?
- Discussions of the group included:
  - Concerns Solar Fields + 5 acres or more (is that really viable in Portsmouth?) To change ordinances takes a lot of leg work, including public hearings, etc.
  - Residential solar/rooftop is already allowed, but not allowed in the historic district (Revision does this a lot)
  - One option is to reach out to a contractor that is doing solar farms (Valentina is reaching out to her contact, John Branagan) and could present to our Committee or at the very least inform the letter to City Council
- Here are NEXT STEPS/ACTIONS for this Committee:
  - Peter, Theresa, John, Carrie to draft a letter to City Council with recommendations on how to respond to Tom Morgan's request.
  - Draft will be circulated with the SPC committee within the next two weeks. Include the following elements:
    - o our SPC Mission, Eco-Municipality and Drawdown Framework
    - Mention why solar is a priority, remove any impediments
    - lean on some of York 100's work -<u>https://yorkreadyfor100.org/ecohomes/community-solar/</u>

#### 5. Amending Building Codes

- Becca brought up the topic of tightening or greening our building codes to cope with new development and we can address or require certain building materials, efficiencies, energy consumption, etc.
- Peter said that there are tighter codes now with insulation, etc. but we could do more. We must follow the State codes and then can amend for tighter codes than the state. This may be an issue for the Planning Board but it would be good to become more educated as a Committee.

- The group came to the consensus that we cannot see our building codes as the lowest common denominator
- Aubrey is very interested in this sector and has a keen interest
- The exciting thing about building codes is that all entities fall under the code, it could have a big impact including: residential, business, commercial and city buildings.
- For example in Cambridge, MA they set a NET ZERO target and will strive to meet that goal by amending building codes.

  - We need to learn about timing, what's up for renewable or re-adoption
  - Perhaps we can have Juliet from the Planning Department come to speak or the Portsmouth Facilities Manager.
  - Peter will think about a speaker for our next CSP meeting April 22, 2021
