I read with some concern your recent opinion regarding a second FBO at the Tradeport. My immediate question is; since when did City Council get into the business of deciding what businesses should and should not locate to the City? As a City Councilor I would think your duty is to distance yourself from financial matters concerning private industry. It certainly doesn't seem to lie within the duties of a City Councilor, and it leaves open the question is there some other motivating factor.

Whether it's an FBO or Joe's hot dog stand, all businesses in a free market have the right to establish themselves as long as they comply with zoning, land use and other restrictions imposed by local governance. The owner of Port City raises a fight anytime there is a potential newcomer to the airport which might threaten his monopoly...and why wouldn't he?

I've been involved with aviation for more than thirty-five years. Fuel sales are the primary revenue source for most FBOs. But it also must be understood fuel prices, which are driven down by competition, are a huge draw and motivating factor for aircraft to utilize the services of an FBO(s). Competitive fuel prices will actually increase aircraft traffic and total fuel sales as aircraft operators "tanker" fuel wherever they can obtain the best price. As you alluded to, FBO's and aircraft traffic bring with it a host of peripheral jobs and financial benefits which spread beyond the FBO and into the local economy. There are very few major airports in the Country where only one FBO has a monopoly. And when they do, I can assure you fuel and other supporting services reflect this lack of competition. Concern over military contract fueling is also puzzling. Jet fuel is all the same, so isn't it in the best interest of the military and ultimately the taxpayer to obtain!

fuel at the most competitive price possible?

The concerns raised over an additional fuel farm are also unfounded. Fuel farms are installed and operated at thousands of airports across the country. Their installation and use are highly regulated by local and Federal guidelines. I don't recall any push back or concern over Port City's fuel farm, which by-the-way has operated safely for many years.

I'm quite concerned by the actions of so many on this City Council speaking out against this proposal. It's not the responsibility of the Council, or any public governing body to bias one business over another. There will always be demand for FBO services at the Tradeport. The success or failure of which will be decided by the best business model and ultimately the consumer.

Some years ago there was a serious collision between a cyclist and a motor vehicle at the intersection of Islington St and Cabot. An adult cyclist was heading downhill on the sidewalk and collided with a motorist making a left turn into the former gasoline station. It was necessary to call for an ambulance. There are three similar intersections on Peverly Hill Road at the bottom of steep downhills that pose the same danger, to a speeding cyclist on a sidewalk.

I would like to discuss the projected improvements on Peverly Hill Rd. I understand that recently there has been a sudden change to the 12 years worth of planning for the upgrade to this section of road with the removal of a planned "separate shared use lane." I strongly urge the council to reinstate the plan with the inclusion of a separate shared use lane.

When deliberating please consider the following:

- 1. Greater tax revenue in the future: This area will soon be the site of 57 new housing units by TF Moran. Please see article from the Portsmouth Herald, February 12th. 57 new homes will certainly need a safe mode of transportation to the shopping centers at the intersection of Peverly and Rt 1. The Moran plan plainly cites their dedication to link the development to the Boston Maine Rail Trail. If the Moran development is marketing to cyclists then a protected lane will absolutely be a value improving item. We all know a greater property value means a greater tax revenue.
- 2. Safety: Peverly Rd as it stands is winding, and prone to overspeeding. It is not an attractive area to walk, jog, cycle, or skate. The addition of a lane that will accommodate alternate modes of transportation will be of greater service to the broader community. For those that would argue "we do not see that use now," it is only because currently Peverly Hill Rd is unsafe for any use aside from driving. Council member Whelan, this should be of especial note to you.
- 3.Opportunity/Convenience: As this will be new construction the town has an opportunity to shape the project, rather than retrofit to community needs. Going with the original project plan, including a separate use lane, now is the most cost effective.
- 4. Value: In both financial and moral sense. A separate lane improves the value or Portsmouth. In a moral sense this is the expansion of access to young people, and those without a vehicle. Giving greater access to the YMCA and to the shopping centers at Market Basket (for work and commerce). In the fiscal sense a separate lane will improve our standing for "Clean Air/Environmental grants," as well as improve home values along Peverly and into Elwyn Park.

To close, please do not let this decision be about the previous battle over "Bike Lanes." I know that there was a great deal of acrimony. Islington lost bike lanes it had because of the wide sidewalks that were added during the upgrade of the street. To calm down traffic on Peverly Hill Rd. the city could use the same type of speed bumps such as found on Maplewood Ave, and a shared walkway with the bikes could be done on Peverly roadway. In response to a recent posting of mine on the Neighborhood web-cite (in which I spoke of the use of the speed bumps on Peverly) somebody wrote that the speed bumps would cause a problem for the cement trucks and semi-trucks that travel this neighborhood St. My answer to that is, Peverly Hill Rd. is a neighborhood street which these trucks are using to reach a destination and slowing down and calming vehicle traffic is consequently one of the main objectives here. This would slow down the traffic and would not have to take away most of the front yards, while giving the residents a sidewalk shared with bikes in the same project. I don't believe that the elaborate design that was submitted a few years ago is anything that the residents really want or need for this project.

One other Item I have is that when the city puts out its Daily News Letter it would be helpful to have separate listings in the beginning of the letter highlighting of the new topics contained in it. This would help those of us who read it to know what is new besides the repeated information that is posted in it. I've also sent a letter to the City Manager on this subject.

comments: Greetings City Councilors —

My name is Eugene Zakharov. My partner, John Tilton, and I own and reside at 541 Peverly Hill Rd. One of our neighbors today brought to our attention that there was a City Council vote on April 5th (following the project walkthrough on April 3rd) requesting a delay in a Public Necessity Hearing and asking for an additional report regarding the installation of just a sidewalk along the roadway. Our neighbor also mentioned that there appears to be a misconception that people on our street are not in support of the project or the current design.

I'd like to understand the opposition, if that is indeed the case, because that's not what we are hearing and that's not the impression we received at the walkthrough or other discussions.

Moreover, and specifically the neighbors that we have spoken to, including Carol Ruesswick at 545 Peverly, Laura Frazer at 539 Peverly, Julia and Jay Goldsmith at 515 Peverly – among many others – have been in support of the project and the current design.

There are at least two issues with just having a sidewalk along the roadway. First, one of the main reasons for the project is to reduce the speed on the road. By eliminating the multiuse lane and widening the roadway to accommodate bikes in it, we are going to potentially have the opposite effect with creating more space, straighter path for speeding. Second, the town will still need to obtain all easements and it's not going to be better for the owners who are most impacted anyway.

We'd rather not be wasting time for additional design and other options – it's been 20 years in the making. I'd like to voice our support of the project and hope for an expedient resolution and moving to the next steps of approval and implementation.
