Re Portsmouth Prosecution Data Analysis

On October 6, 2020, in collaboration with Stephanie Hausman, and with the endorsement of more than one hundred other Portsmouth residents, we submitted a letter to the Portsmouth Police Commission which outlined multiple requests for transparency and accountability measures at the Portsmouth Police Department. Request #7 asked the Commission to request that prosecuting agencies provide case-outcome information, including information regarding court rulings about the legality of police conduct, case disposition, and sentence. Request #8 asked the Commission to analyze case-outcome data in consideration of constitutional norms; anti-racist, anti-discriminatory policies; and community policy goals; and to make this data publicly available.

We later explained that prosecution data would contribute necessary information to the following inquiries: 1, Equity question: Does law enforcement have a disproportionate impact on historically marginalized groups – for example, people of color, people with mental health issues, and poor people? 2, Policy question: Are actions taken by public safety officials consistent with community policy goals? 3, Fiscal question: How are public safety resources are being allocated?

As an interim response to these requests, on March 9, 2021, the Portsmouth Police prosecutor provided us with copies (attached) of the types of documents typically kept in prosecutors' files. Many types of data relevant to Requests #7 and 8 reside in those documents. Below, we've identified the types documents and the types of data available—and not available—in the documents. We are providing this information to you because we believe that it will be helpful for you to see what data we're interested in and where it might be harvested from.

It bears emphasizing that we are a resident-advocacy group. Although we have been working consistently and collaboratively with members of the Portsmouth Police Commission and Police Department on transparency and accountability measures for more than six months, we do not work for or represent these agencies. As we discussed when we spoke on April 9, we need to ensure the Commission and Department are on board with a plan for the collection and analysis of this data. It would be helpful to have your insight into the scope of such a project.

Available Portsmouth prosecution statistics

The Portsmouth Police Department Strategic Plan for 2021-2025, p. 16, reports the following statistics on fiscal year 2019 prosecutions by Portsmouth City prosecutors: Cases/Charges resolved = 805; Guilty = 486; Not Guilty = 15; placed on file = 97; Nol Pros = 207; trial subpoenas issued = 284.

This limited data is of questionable utility, particularly since its primary identifier, "Cases/charges," is not defined. A prosecution "case" might presumably involve several "charges"; if the number of cases and charges has been aggregated, it is not clear how that total provides useful information. It is also unclear how the 805 resolved cases/charges relates to the 1,857 arrests made and 424 traffic citations issued by the Portsmouth Police Department in 2019.
