PART 1 - GENERAL

1.1 SUMMARY OF WORK

- A. Project: Spinnaker Concrete Repairs**
- B. Owner: City of Portsmouth NH**
- C. The Work consists of removing and disposing of existing concrete slabs and stairs as indicated on the drawing and directed in the field, and replacing with new concrete slabs and stairs. Work will comply with NHDOT Sections 608, 203 and 209 except as amended in the contract documents.**
 - 1. Preparation of subgrade beneath each slab to be replaced. Excavation for new slab will be to a depth of 12" below finish grade.
 - 2. Forming and pouring a minimum 4" slab(s) of 4000 psi poly fiber mix reinforced with 6" x 6" 10 ga welded wire mesh.
 - 3. Replacement of concrete steps with new precast or cast in place stairs.
 - 4. Sealing of all new concrete.
- D. Testing: The Owner will provide testing services for the subgrade and concrete.**

1.2 WORK RESTRICTIONS

- A. Contractor's Use of Premises: During construction, Contractor will have limited use of area indicated. Contractor's use of premises is limited as follows:**
 - 1. Owner will occupy premises during construction. Perform construction only during normal working hours (7 AM to 6 PM Monday thru Friday, other than holidays), unless otherwise agreed to in advance by Owner. Clean up work areas and return to a useable condition at the end of each work period.
 - 2. The Work will occur at the main entrance to a working facility. Safe access for the general public shall be provided for all who use the facility during construction.
