ADDENDUM NUMBER 4: Bid#10-16

South Mill Pond Tennis Courts, Leary Ball Field Lighting and Portsmouth High School Lighting Issued: January 11, 2015

This Addendum forms part of the original document marked: Bid#10-16 South Mill Pond Courts, Leary Field Lighting and Portsmouth High School Lighting.

General Bid Clarifications

- 1. At Leary Field there is netting attached to the lighting pole on the first base side. The contractor shall leave the pole in place, remove and dispose the electrical boxes, conduit and lighting from the pole and cut off the pole three to four feet above the attached netting. The top portion of the pole shall be disposed of properly.
- 2. On sheet L3.03 High School Site Preparation and Lighting Plan, relocate the construction entrance per SK-4.
- 3. In general, disturbance location and hatches are shown schematically. The contractor shall protect existing surfaces, turf, asphalt, and concrete sidewalk as well as possible. Any surface disturbance during construction shall be replaced/ restored in kind.
- 4. Please refer to the attached sheet SK-5 for a detail of the cheek wall.

The following questions have been asked and answered.

Question 1:	Are we supposed to use sand borrow as backfill in our electrical conduit runs? The detail doesn't show it nor do the specs.
Answer:	Backfill may be made with excavated material or comparable. Backfill shall be free of frozen lumps and rocks larger than 2", debris and rubbish. Organic materials shall not be used. Backfill shall be thoroughly compacted in six inches layers. Care shall be exercised to avoid damage to conduits during backfilling.
Question 2:	The plans call for VA-4 granite curbing in a 4" width. MASSDOT VA-4 M9.04.01 states that VA-4 is 6" wide. Would you like us to provide VA-4 in its true form at 6" thick or VB which is 5" thick? Please specify dimensions for this curbing. Specified material doesn't match what it is referring to in MASSDOT specs.
Answer:	The granite curbing shall abide by the parameters of a VA-4 granite curb, but have a width of 4".
<u>Question 3:</u> Answer:	Are we to include windscreen in the gates as well, passenger and double drive? Yes, the gates, passenger and double drive, will include windscreens.
Question 4:	Please clarify the limits of base bid curbing. If alternate 3 is not accepted then where does this curbing end?
Answer:	Please refer to the attached sheet SK-3 for clarification.
Question 5:	In base bid, does the bituminous concrete walkway wrap around the corner at the southwest corner? Please confirm the limits of the bituminous concrete walks.

Answer:	Yes, in the base bid, the bituminous concrete walk will wrap around the
	southwest corner of the tennis courts and meet with the existing pathway.
	Please refer to the attached sheet SK-3 for further clarification.






