REQUEST FOR PROPOSALS

INVITATION

The City of Portsmouth is soliciting Proposals from qualified contractors to provide sewage sludge hauling for the City of Portsmouth.

<u>Sealed</u> Request for Proposals, <u>plainly marked RFP # 16-17</u> "<u>Sewage Sludge Hauling – City of Portsmouth</u>" on the outside of the mailing envelope as well as the sealed envelope, addressed to the Finance/Purchasing Department, City Hall, 1 Junkins Avenue, Portsmouth, New Hampshire, 03801, will be accepted until November 14, 2016 at 2:00 p.m..

The City of Portsmouth reserves the right to reject any or all proposals, to waive technical or legal deficiencies, to accept any proposal and to negotiate the terms of any final contract that may be in the best interest of the City.

SECTION I - GENERAL INFORMATION

- A. The City is requesting proposals from qualified firms to provide pricing for removal and transportation of wastewater treatment plant solids (hereinafter "sewage sludge") from both the Pierce Island Wastewater Treatment Facility located at 200 Peirce Island Rd, Portsmouth, NH, and the Pease Wastewater Treatment Facility, 135 Corporate Dr, Portsmouth, NH. Sewage sludge are to be transported to the Waste Management's Turnkey Landfill at Turnkey Way, Rochester, NH.
- B. Sewage sludge are stored in 30 yard roll-off containers at both facilities. Removal of sewage sludge shall be done at a minimum once daily, four days a week from the Pierce Island WWTF and once daily, one day a week from Pease WWTF. Additional days of hauling may be necessary based on volume of sewage sludge collected at each facility. The City will notify the vendor 24 hours in advance if additional removal will be needed.
- C. - D. The proposer shall participate in good faith in the process, being mindful of the intent of the project work scope and not take advantage of any error or omission.
- E. The work may commence any time after acceptance as scheduled with the City.
- F. Upon the mutual agreement of both parties, this agreement may be renewed in one-year increments at rates negotiated at the time of renewal for a total period not to exceed three (3) years.

SECTION II - PROJECT WORK SCOPE AND REQUIREMENTS

The Pierce Island Wastewater Treatment Facility utilizes ferric chloride and polymer to enhance primary treatment of municipal wastewater. The primary sludge is processed using belt filter presses to a concentration of approximately 28-32 percent dry solids. Permanganate is added to the sludge for odor control.

The Pease Wastewater Treatment Facility generates both primary and secondary sludges from treatment of both industrial and municipal wastewater. The combined sludge is processed using a belt filter press to a concentration of approximately 17 to 20 percent dry solids.

Contents of each container may weigh between 11 and 18 tons. Permanganate is added to the sludge for odor control.

Project requirements are as follows:

- A. Remove sewage sludge from the wastewater treatment facilities; furnishing all of the necessary labor and appropriate vehicles to accommodate sealed 30-yard roll-off containers during transport.
- B. Hours of Operation: All work shall be performed during daylight hours Monday Friday between 6:00 am to 1:00 pm. The wastewater treatment facilities will be notified daily prior to the removal of sewage sludge at (603) 427-1553 or in person. No work may take place from 1:00 p.m. on Fridays to 6:00 a.m. on Mondays, nor on Holidays during the work period, without prior approval from the City. Periodically hauling may be requested as early as 6 a.m. with 24 hours prior notice to the Contractor.
- C. The Contractor will provide a price per hour to transport the sewage sludge from both wastewater treatment facilities to its ultimate utilization/disposal location. This price shall be held for one year after signing of the contract.
- D. Contractor's failure to perform its work in accord with these requirements, including timely response to requests for additional hauling, satisfactory coordination with City operational staff and safe operation will result in termination of services.
- E. The Contractor will maintain throughout the course of the engagement insurance coverage that at a minimum meets the requirements set forth in Attachment A.

SECTION III - SUBMITTAL REQUIREMENTS

Proposals must be submitted in a sealed envelope, and shall be addressed to the City at the address and to the attention of the official as outlined in the invitation. All proposals must be submitted prior to the specified date and time. Any proposals received after the specified date and time will not be considered and will not be opened. Proposals delivered via facsimile, e-mail, or any format other that within a sealed envelope shall not be considered.

Proposals shall include:

- 1) Cover letter introducing the firm and providing a summary of company resources, experience and expertise;
- 2) Completed Price Proposal Form (attached);
- 3) Confirmation that Contractor can meet the insurance requirements described in this RFP; and
- 4) At least three (3) references from other municipalities in New Hampshire where the Contractor has provided similar services with the Proposal (contact name, address, phone/email. Description of project, tonnage, outlet, and date of service).

Proposal shall be open for acceptance for sixty (60) calendar days from the date of submittal to the City of Portsmouth.

A proposer will be permitted to withdraw their proposal unopened after it has been deposited if such request is received in writing prior to the time specified for opening the proposal.

SECTION IV - SELECTION

Selection shall be based: (1) Contractor's qualifications, experience and resources (2) satisfactory past performance and (3) price. Proposer must have a minimum of 5 years of experience in the hauling of sewage sludge.

Upon selection, Contractor will receive a service contract substantially in the form attached hereto as Attachment C and will be expected to complete negotiations on a final contract and execute within 14 business days of receipt. If the parties cannot agree on the final contract terms and scope, the City may proceed to another proposer.

SECTION V – RESERVATION OF RIGHTS

The City of Portsmouth reserves the right to reject any or all proposals, to waive technical or legal deficiencies, to accept any proposal and to negotiate the terms of any final contract that may be in the best interest of the City.

By submitting a proposal, the Contractor authorizes the City to undertake such investigation as may be necessary to verify the Contractor's qualifications and reputation. The Contractor may be requested to execute a release(s) in favor of third parties who have information relative to the Contractor's qualifications and reputation. Refusal to execute a release may result in disqualification.

INSURANCE REQUIREMENTS

Insurance shall be in such form as will protect the Contractor from all claims and liabilities for damages for bodily injury, including accidental death, and for property damage, which may arise from operations under this contract whether performed by Contractor or by anyone directly or indirectly employed by Contractor.

AMOUNT OF INSURANCE

- A) Comprehensive General Liability:
 Bodily injury or Property Damage -- \$2,000,000
 each occurrence and general aggregate
- B) Automobile and Truck Liability:
 Bodily Injury or Property Damage -- \$2,000,000
 each occurrence and general aggregate
- C) Pollution Liability -- \$1,000,000

Comprehensive General Liability coverage and Automobile and Truck Liability coverage may be met with a combination of coverage including excess and umbrella liability coverage.

TYPES OF INSURANCE FOR CONTRACTOR

Purchase and maintain the following types of insurance:

- A) Workers Comprehensive Insurance coverage as required by the most current laws of the State of New Hampshire.
- B) Product and Completed Operations coverage to be included in the amounts specified above for Comprehensive General Liability.
- C) Pollution Liability Coverage

CONTRACT AGREEMENT SEWAGE SLUDGE HAULING

THIS AGREEMENT is made as of the day of in the year 2016 by and between the City of Portsmouth, New Hampshire (hereinafter call the Owner) and
(hereinafter called the Contractor). Owner and
Contractor agree as follows:
ARTICLE I - Work - The Contractor shall provide at its expense, all labor, materials, equipment and incidentals as may be necessary for the expeditious and proper execution of those services described in the Scope of Work and Project Requirements referred to in RFP # 16-17 and incorporated herein.
ARTICLE II – PROJECT MANAGER - The Public Works Project Manager, or his/her authorized representative, will act as contact in connection with the scheduling and authorization of services in accordance with the contract documents. Scheduling of project work may be confirmed or memorialized by e-mail or purchase order.
ARTICLE III - CONTRACT TIME - The initial contract period will commence on and end on

ARTICLE IV - CONTRACT PRICE - Owner shall pay Contractor for performance of the work in accordance with the Price Proposal Form.

ARTICLE V - PAYMENT – The Contractor shall invoice the Owner within 30 days of completion of the work performed or monthly.

ARTICLE VI – RENEWAL PERIOD-It is the intent of this proposal to establish a contractor for sewage sludge hauling services for a period of one year with a yearly option to extend the contract. Both the City of Portsmouth and the Contractor must agree on any extensions beyond the first year, but not to exceed a total of three years.

ARTICLE VII - TERMINATION FOR DEFAULT - The City of Portsmouth may terminate this Contract with seven (7) day notice should the Contractor fail to perform work in accord with the Scope of Work and Project Requirements. Failure to maintain any and all licenses necessary to perform the work and/or to maintain insurance coverage is grounds for immediate termination of the Contract.

ARTICLE VIII - INDEMNIFICATION OF CITY - Contractor will indemnify City against all suits, claims, judgments, awards, loss, cost or expense (including without limitation attorneys' fees) arising in any way out of the Contractor's negligence or breach of its obligations or warranties under this Contract. Contractor will defend all such actions with counsel satisfactory to City at its own expense, including attorney's fees, and will satisfy any judgment rendered against City in such action.

ARTICLE IX - PERMITS - The Contractor will secure at its own expense, all permits and consents required by law as necessary to perform the work and will give all notices and pay all fees and otherwise comply with all applicable City, State, and Federal laws, ordinances, rules and regulations.

ARTICLE X - INSURANCE - The Contractor shall secure and maintain, until acceptance of the work, insurance with limits not less than those described in the attached Insurance Requirements.

ARTICLE XI - MISCELLANEOUS -

- 12.1 Neither Owner nor Contractor shall, without the prior written consent of the other, assign, sublet or delegate, in whole or in part, any of its rights or obligations under any of the Contract Documents; and, specifically not assign any monies due, or to become due, without the prior written consent of Owner.
- 12.2 Owner and Contractor each binds himself, his partners, successors, assigns and legal representatives, to the other party hereto in respect to all covenants, agreements and obligations contained in the Contract Documents.
- 12.3 This Contract shall be governed by and construed in accordance with New Hampshire Law.
