FUNDING

The design portion of this project will be funded by sewer revenues.

MANDATORY PRE-PROPOSAL MEETING

There will be a **mandatory pre-proposal meeting on October 30, 2007 at 9:00 a.m.** at the Department of Public Works 680 Peverly Hill Road, Portsmouth, NH. All firms will have an opportunity to ask questions and tour the area at this meeting.

PROJECT BACKGROUND/PURPOSE

Through sanitary surveys a number of businesses in the area have been identified as having failed septic systems which are impacting water quality. Given the difficult soil conditions and the lack of available space the affected property owners have requested the extension of sewerage service to eliminate this problem. In addition, the New Hampshire Department of Environmental Services (NHDES) has identified the Sagamore Creek in their recently completed Total Maximum Daily Load for Little Harbor.

A preliminary design report was prepared by Altus Engineers Inc. in which a number of options were evaluated to provide sewerage to the area. However, the alternatives investigated did not include low pressure sewer.

SCOPE OF WORK

The scope of work shall be sufficient to address the following:

• Evaluation of feasible alternatives to provide sewer service to this area of the City. This will include a letter report which will fulfill State Revolving Fund and State Aid Grant requirements.

- Prepare design drawings and specifications for the construction of selected sewerage system to the Sagamore Avenue South.
- Prepare and submit necessary permits for completion of this project.
- Attend public informational meeting to review project with impacted property owners.
- Submit the 100% design to the NHDES for review and approval to bid.

Project Deliverables shall include, at a minimum, the following:

- 1. Preliminary Design Letter Report
- 2. Three (3) sets of 75% Design Plans for City review and comment.
- 3. Four (4) sets of 100% Design Plans, Specifications, and Necessary Forms for NHDES to review and comment.
- 4. Provide one (1) unbound reproducible copy and a Digital copy of the approved design plans and specifications to the City.
- 5. Consultant's opinion of probable construction costs based on the 100% Design.

The Consultant shall include in their scope of work the number of site visits and/or meetings with the City or NHDES staff necessary to satisfactorily complete the project. The consulting engineering firms must be on the NHDES roster of pre-qualified consulting engineers. The City reserves the right to negotiate directly with the firm selected for additional project work including construction administration services, and/or additional project engineering and design services.
