GENERAL CLARIFICATIONS

1. Question: 1st page of bid document references "Pavement Markings", are there pavement markings as part of this bid?

Answer: No, there are no pavement markings in the bid.

- Question: Is there a bid bond required? Are there final bonds required?
 Answer: No bonds are required for this bid
- Question: Please provide a specification/drawing of the breaker and/or electrical demark components you would like installed inside the traffic signal cabinets
 Answer:

The Deer St Signal cabinet has a 100 Amp Square D panel mounted to it. Install a new Square D QO breaker for the lighting. Pass through the cabinet wall with the wiring and into the conduit system which begins inside the cabinet.



The Hanover St Signal cabinet subpanel is fed from the Deer St cabinet with a 60 Amp double pole breaker. Install a new Square D QO breaker for the lighting in the sub-panel. Pass through the cabinet wall with the wire and into the conduit system which begins inside the cabinet. The 20 amp breaker shown below is the only breaker currently in the panel and runs the signal. Picture of inside the Hanover sub-panel:



The new Congress St Signal cabinet has no panel or subpanel. Provide new "din rail" style breaker in the empty space inside the cabinet and label it properly to maintain UL rating.
