Sealed Request for Proposals, plainly marked RFP # 32-06, "Engineering & Design Services, Pleasant Point Area Sewer Extension" on the outside of the mailing envelope, addressed to the Finance/Purchasing Department, City Hall, 1 Junkins Avenue, Portsmouth, NH 03801 will be accepted until 2:00 p.m. on February 2, 2006.

#### **FUNDING**

The design portion of this project will be funded through a \$30,000 grant from the New Hampshire Estuarine Program as well as sewer user rates. The Construction phase of this project will be funded through a State Revolving Fund loan.

#### MANDATORY PRE-PROPOSAL MEETING

There will be a **mandatory pre-proposal meeting on January 19, 2006 at 1:30 p.m.** at the Department of Public Works 680 Peverly Hill Road, Portsmouth, NH. All firms will have an opportunity to ask questions and tour the area at this meeting.

#### PROJECT BACKGROUND/PURPOSE

Through sanitary surveys a number of homes in the area have been identified as having failed septic systems which are impacting water quality. Given the difficult soil conditions and the lack of available space the affected residents have requested the extension of sewerage service to eliminate this problem. In addition, the New Hampshire Department of Environmental Services (NHDES) has identified sewerage extension to the Pleasant Point Area as a priority in their recently published Total Maximum Daily Load Study for the Little Harbor Area.

A preliminary design report was prepared by Underwood Engineers Inc. in which a number of options were evaluated to provide sewerage to the area. Based on this study the most cost effective solution is the installation of a low pressure sewer system. The intent is to utilize the E-One low pressure system.

#### SCOPE OF WORK

The scope of work shall be sufficient to address the following:

• Prepare design drawings and specifications for the construction of a low pressure sewerage system to the Pleasant Point.

- Prepare and submit necessary permits for completion of this project.
- Submit the 100% design to the NHDES for review and approval to bid.

Project Deliverables shall include, at a minimum, the following:

- 1. Three (3) sets of 75% Design Plans for City review and comment.
- 2. Four (4) sets of 100% Design Plans, Specifications, and Necessary Forms for NHDES to review and comment.
- 3. Provide one (1) unbound reproducible copy and a Digital copy of the approved design plans and specifications to the City.
- 4. Consultant's opinion of probable construction costs based on the 100% Design.

The Consultant shall include in their scope of work the number of site visits and/or meetings with the City or NHDES staff necessary to satisfactorily complete the project. The consulting engineering firms must be on the NHDES roster of pre-qualified consulting engineers.

The tentative schedule pending available SRF funding will be to complete the design effort by June 2006 for summer 2006 bid and construction. The City will work with the successful consultant to finalize the schedule.

#### CITY ROLE

City staff will be responsible for administering the project and overseeing the consultant's work on this project. Representatives of the City's Public Works Department will review plans and other documents prepared by the consultant.

Information will be available for the Consultant's review after the pre-proposal meeting. This information will be located the Public Works Department, 680 Peverly Hill Road, Portsmouth, NH from 8:00 a.m. to 4:00 p.m. Monday through Friday.

Proposals shall include the following:

- Scope of work.
- Project schedule, organized by task.
- Names and qualifications of specific project staff that will play the primary role in this project.
- Level of man-hours effort by task.
- Fee schedule.
- Three (3) references, including <u>current</u> contact name and phone number for similar project.
- Four (4) copies of the proposal must be submitted.

- 4. Firm qualifications, and experience.
- 5. Descriptions of and references for similar projects performed in New England, specifically those in New Hampshire. References shall include contact person and telephone number.
- 6. Identification and description of project team and staff who will perform the project.

The City of Portsmouth reserves the right to reject any or all proposals, to waive technical or legal deficiencies, and to accept any proposal that it may deem to be in the best interest of the City. The City reserves the right to negotiate directly with the firm(s) selected for additional project work including construction administration services, and/or additional project engineering and design services.

The City also reserves the right to make such inquiries regarding the firm's qualifications and reputation as it deems necessary to evaluate the firm. The firm may be requested to execute releases to obtain information from third parties. Failure to execute a release upon request may result in disqualification.

The contract documents shall utilize the NHDES SRF front end. All information, data, documents, photos, computer records, and other materials of any kind acquired or developed by the consultant pursuant to this project shall be the property of the City of Portsmouth.
