(note, this is part of Bid Alternate #1).

QUESTIONS

- 1. Drawing E-1, Bid Alternate call for (2) sets of 3-500 KCMIL conductors from the pad mount transformer to the new 400a breaker, is (2)sets correct or should it be (1)?

 1A: There should be one set as indicated on the one-line diagram on Drawing E-5.
- 2. Is there adequate space in the existing GE Spectra Electrical Panel at Well#2 to install a new 110a 2 pole breaker?

 2A: This is unknown. The covers have not been removed from the panels. Contractor must field verify.
- 3. Can the fiber optic cable be installed in PVC conduit below grade from Well#5 to the FWPS, spec says no PVC on data, signal or phone cables?

 3A: No. The Owner has requested rigid galvanized conduit for control signals.
- 4. Is there adequate space in the existing Electrical panel in the FWPS to accept a new 300a 3 pole breaker?

4A: It appears the new breaker should fit in the breaker space that now feeds existing Well #4 building, and which will be removed from the feed now present and re-powered on the new circuit. Contractor to confirm.

5. Are there AIS requirements for the project? 5A: No, there are no AIS requirements for the project.
