## ADVERTISEMENT FOR BIDS Sagamore Road Reconstruction- Phase 1

Sealed BIDS for the construction of: **Sagamore Avenue Reconstruction– Phase 1** will be accepted by the City of Portsmouth Finance/ Purchasing Department, City Hall, 1 Junkins Avenue, Portsmouth, NH 03801 until **2:00 PM, July 2, 2014**, and then publicly opened and read aloud. The project includes Reconstruction of approximately 2,500 linear feet of Sagamore Avenue between South Street and Little Harbor Road in Portsmouth. Roadway work will include full depth reconstruction, replacement of a sidewalk, addition of bicycle lanes, addition of drainage structures and piping, replacement of sewer over the entire length, modifications to water service, realignment of the intersection of Sagamore Ave and Little Harbor Road, landscaping, and ancillary work. There will be a **mandatory pre-bid meeting** on June 24, 2014 at 10 AM. The pre-bid meeting will be held in the conference room located on the first floor of the Portsmouth Public Works Building located at 680 Peverly Hill Road in Portsmouth, NH

- Completion time for the project will be calculated as 150 calendar days from the date specified in the "Notice to Proceed". It is anticipated that a Notice to Proceed will be issued on or before <u>July 21</u>, <u>2014</u>. Final Completion must be reached by April 30, 2015.
- Liquidated damages for this project will be in accordance with the following schedule: <u>\$1,000.00</u> for each day of delay from the date established for Total Project Substantial Completion. <u>\$500.00</u> for each calendar day of delay from the date established for Contract Completion.
- 3. Each General Bid shall be accompanied by a bid security in the amount of 10% of the Total Bid Price.
- 4. The successful bidder must furnish 100% Performance and Payment Bonds and will be required to execute the Contract Agreement within 10 days following notification of the acceptance of his bid.
- 5. No Bidder may withdraw a Bid within 60 days after the actual date of opening thereof.
