Work also includes road reconstruction, sidewalk and curbing. - Bids will only be received by Contractors who have been prequalified by the City. If you are not currently

 submissions (and updates) must be received by January 25, 2006. You will be notified within 15 calendar
 days if you have been prequalified. Contractors previously qualified for Contract #1 will be reconsidered for
 Contract #2 as long as they provide an updated list of current projects and financials (see Attached Form –
 Part V of the prequalification request) which demonstrates to the satisfaction of the City of Portsmouth that
 the Contractor continues to be qualified for this project. These are also due on or before January 25, 2006.
