Office of Economic Development Update: (newly created)

The OED has two initiative underway; the first is to purchase customer relationship management software to support connection and communication with our business community and the second; a regional employer outreach program designed at support employers in understanding the best practices around attracting and retaining employees. Both initiatives will be reported on in more detail at the next EDC meeting. The Small Business Administration (Federal) contacted the OED with an inquiry to host an event in Portsmouth on the topic of entrepreneurship and how we as a city can support entrepreneurs. What is SBDC hearing from small businesses and other observations –

- Staffing is a challenge
- Workforce housing (related to staffing) is a challenge
- Employee retention is a challenge

Small businesses are moving past survival and into a growth mindset of not phase.

- Many SBDC members report strong balance sheets (opportunity)
- Many members are planning to strategically add staff (opportunity)
- Side hustles are on the rise for many SBDC members
- Commercial lending is available

There is a trend of healthcare professionals wanting to leave large organizations and start their own practice.
