Mayor McEachern and Members of the Council,

I have perused the proposed FY 2025 Budget and note that it contains 748 pages. Its length rivals that of War and Peace and the King James Bible.

While I understand that its length reflects your commitment to transparency, I submit that the sheer volume is overwhelming for the average citizen.

I stress that point because the idea that you can deal with this budget primarily in one marathon work session on May 13th boggles my mind and exceeds my attention span and I suspect that of others.

The primary purpose of a budget work session is not for your benefit, who have greater familiarity with city departments and expenditures, but for that of the taxpayers who have to deal with the ramifications of the budget you adopt.

As such, we should not be expected to absorb everything about this budget primarily in one six hour marathon work session. Prior Councils had multiple budget work sessions .This approach gave both the Council and the public the opportunity to gradually learn about and comprehend the contents of the budget .

I urge you to schedule multiple shorter work sessions as opposed to a marathon one. Specifically I propose that you cancel toe 9 to 3 May 13th work session and instead schedule three two hour evening sessions, the first on May 14th, the second on May 20th (already scheduled) and the third on May 28th (the 27th being Memorial Day.) Take the time to do it right and give taxpayers the opportunity to better understand the budget over time, not all at once.

I also note that a public hearing is scheduled for May 13th. If you still opt to proceed with the 9 to 3 work session, the ,public hearing should not take place that night. Not everyone will be able to attend the 9 to 3 work session, but both they and those who do attend need time to learn about and absorb what was said and have more than a few hours to reflect on what they want to say at the public hearing. I would propose that the initial public hearing take place on June 3rd with a continuation and adoption of the budget on June 17th.

I also note that there is reference to Listening Sessions on the agenda for the May 13th work session.

In a traditional public hearing the public talks at the Council and there is no opportunity for give and take Not everyone feels comfortable speaking at a public hearing.

Last year the Council split into teams and held Listening sessions at various venues. I attended one, enjoyed it and found that people felt more comfortable addressing the Councilors and that there was an opportunity for meaningful give and take. I urge you to schedule Listening Sessions again this year.

Finally, I want to talk about the Elephant in the Room, namely the revaluation. In her Budget Message, the City Manager projects a proposed tax rate based, I presume, on current property valuations.

However, as I understand it, , the December tax bills will be based on the property revaluations. If I am correct, I would like to see some discussion of the impact of the revaluations on the proposed budget.
