Glad to see some progress on lifting the city's restrictions on electric vehicle (EV) chargers.

On March 21, the Planning Board voted to remove a major impediment to chargers when they recommended amending the ordinance to expressly permit chargers as an accessory use in much of the city.

Councilor Denton's proposed revisions, as detailed in your April 15 meeting packet, would remove the other major impediment to Level 3 EV chargers (25-minute charge), namely the off-street parking restrictions in Article 11 of the zoning ordinance. Councilor Denton's proposal would grant an exemption to the equipment associated with Level 3 chargers. This may seem like a minor detail, however it can make the difference (and it has) between success and failure.

I am writing to request that you support Councilor Denton's proposed revisions.

Why is this important?

NH DES calculates that the transportation sector accounts for 46% of NH's greenhouse gas emissions. In order to persuade motorists to transition away from fossil fuels, EV chargers must be ubiquitous.

Some 46% of Portsmouth residents are renters. City landlords have little financial incentive to install Level 2 chargers. In the absence of Level 2 chargers at home, Level 3 chargers must be available nearby. Otherwise it is not practical for a Portsmouth renter to own an EV.

Those of us at Seacoast Area Bicycle Riders are looking forward to the creation of a new Bicycle and Pedestrian Plan, and we hope that we can help to identify and prioritize projects that can create a real network in the next 5-7 years. While the 2014 plan was excellent and very thorough, the only time in the last ten years that city staff presented a report to Council on progress was in 2018. We need to do much more to track progress and share plans with the public.

Along very similar lines, I'll point out that our Complete Streets Policy under "implementation" states that "The Planning Department shall make an annual report to the City Council showing progress made in implementing this policy". I'm not aware of this ever happening (unless we count that 2018 bike/ped update). It doesn't seem that the ten "performance measures" have been tracked or reported on publicly either. Are we living up to this policy?

So while a new bike/ped plan is very welcome, if being a "bike-friendly" and "walk-friendly" community is truly a priority then we need to do more each year to track our progress and set our goals in public. A bicycle and pedestrian advisory committee charged with implementation would also be a big help— but I'll write more about that later.
