# CORPORATE DRIVE RECONSTRUCTION PORTSMOUTH, NEW HAMPSHIRE

The following changes and information are hereby incorporated into the Contract Documents (Project Manual and Drawings).

#### **GENERAL**

Additional questions received after Addendum No.3:

Q1: Is the existing granite curb set in concrete?

A1: This information is not known.

Q2: If there is concrete on the face of the existing granite curb, to what extent will the City require us to remove/sandblast off the concrete?

A2: From Question 1 above, it is not known if the existing granite curb is set in concrete. However, salvaged granite curb incorporated into the work shall be reasonably clean, square and uniform. Exposed curb (i.e. reveal) shall be free of concrete and/or other surface irregularities.

#### **PROJECT MANUAL**

#### 1. Advertisement for Bids (A-1.1)

Change the bid opening from September 21, 2023 at 2:00 PM to September 22, 2023 at 9:00 AM in the first sentence of the first paragraph on page A-1.1 as follows:

The Project includes, but is not limited to, drainage, roadway, sidewalk, and stormwater improvements along 6,600 linear feet of Corporate Drive from the vicinity of Goose Bay Drive to Grafton Road."


#### 2. Bid Schedule (A-3.13)
