Addendum 1 Bid 23-25 Traffic Signal Replacement

Question 1: There is a contradiction between bid items and plan notes regarding pavement markings for symbols and words. The plan notes are for thermoplastic, but the item is for waterborne paint. Would you please confirm which product you are requesting?

Answer: It is the City's intention to pave Middle Street as part of the 2025 paving season. Should temporary pavement markings be necessary due to delay of this final paving of Middle Street, waterborne paint will be utilized in a temporary fashion as shown in the base bid until the final paving of Middle Street is completed. Thermoplastic markings would be applied if the street has in fact been resurfaced prior to the new configuration needing to be established. The intent here is to give flexibility depending on the road surface condition.

The bid form has been altered and included herein to include thermoplastic markings as an add/alt to provide flexibility in scheduling. Use this bid form in lieu of the original bid form.

Question 2: Please send over a boring log for the 50-Foot Mast Arm Foundation Traffic Signal Replacement – Middle Street at Summer Street And Miller Avenue.

Answer: The City has not yet conducted a boring so the design in the base bid is based upon the standard NHDOT Type 2 mast arm post foundation. Prior excavations by others at this site indicated that this would likely be appropriate for this project. In case a Type 1 foundation is required, an add/Alt for a Type 1 base has been added (ADD/ALT 4). The Contractor will be required to perform at least one boring necessary to confirm the soil bearing capacity and depth to ledge and the cost for the geotechnical boring and testing shall be at the <u>contractor's expense</u>. Contractor to provide the Engineer with the acquired data for determination of the foundation that will be required. All geotechnical costs shall be incidental to Item No. 616.5, Traffic Signal Post Foundation.

List of major changes in this addendum:

- 1. Item 520 has been added for curb backfill
- 2. Item 645.7 has been removed as there is insufficient ground disturbance to warrant a SWPPP although stormwater controls will still be necessary.
- 3. ADD/ALT 3 has been added in the event the road is overlayed, to provide pricing for permanent thermoplastic markings
- 4. ADD/ALT 4 has been added in the event a Type 2 foundation cannot be utilized and a Type 1 foundation is found to be necessary following the boring and geotechnical work.
- 5. A new BID FORM is provided.
